uring the past year the Sunshine Coast Community Foundation experienced continued growth in assets and in the number of endowments largely as a result of the Barron Estate incentive. Assets now exceed \$3 million. The Foundation's Community Grant Committee was extremely busy under the leadership of Co- Chairs, Elise Rudland and Anne Titcomb. Thirty-six grants amounting to \$40,000 were awarded to local charities and organizations for worthwhile community projects at the June Granting Ceremony.

Succession planning was a major focus in 2012, as in the previous year, due in part to founding directors continuing to transition off the Board. Elise Rudland will be leaving after having her term extended last year. Past Chair, Peter Bogardus, and current Chair, Dale Eichar, are also leaving in 2013 following over nine years of service. In addition, Margaret Page, Gael Johnston and Sandy McBride have stepped down from the Board. We expect a number of the past directors will continue to serve on committees of the Foundation.

Four Directors have joined the Board in 2013. Bill Beamish, a past Director, is returning after two and half years in Queen Charlotte City. New Directors, Chris Fawcus, Vicki Dobbyn and Chris Reid have also joined the Board. All four Directors were

carefully selected by the Board Renewal Committee and are expected to bring a high standard of care to the Board as a result of their demonstrated leadership and business backgrounds. See page 2 for further details.

Executive Director, Sandra Cunningham, has recently completed her first year as a part time employee of the Foundation. Sandra's high energy and dedication were valued attributes as she developed in her new role and helped the Board navigate the Foundation through a period of substantial growth and organizational change.

After a full and productive strategic planning session in October, the Board

came to a general agreement as to the direction in which SCCF needs to move over the next four years. In addition to our on-going responsibilities to manage the endowments and funds that we have and to continue making grants into the community, the two areas that are paramount to our success are financial sustainability and community leadership. Financial sustainability must be achieved in order for the Foundation to continue to operate at our current levels. Community leadership, one of our three pillars, is a means to an end in that it addresses both the health of our community as well as increases awareness of the Foundation and our important role in the community.

Consensus was reached that as we move toward our goals we must focus on both these areas to be successful.

This year marks the 10th anniversary for the Sunshine Coast Community Foundation. A special event is being planned for the fall to celebrate this important milestone for the Foundation. Look for more information and announcements this spring.

We continue to strive to be a valued partner in philanthropy, enriching life on the Sunshine Coast. With our volunteers, sponsors and donors we are working together to "Build a Better Community for Tomorrow, Today".



JUNE 2012 GRANTINGS

In 2012 the Sunshine Coast Community Foundation was proud to grant over \$40,000 to several groups and agencies on the Coast. The causes supported and organizations helped ranged from iPads for the Halfmoon Bay Homework Club to micro-power turbine generation for the Sunshine Coast Salmonid Enhancement Society. Another highlight of the year was the ability of the Foundation to add to existing

endowments through a matching plan thanks to our largest bequest to date from the estate of Vera Barron. Several local societies took advantage of this one-time opportunity to create their own endowment within the Foundation.

Here we shine a light on two of our grantees and a new endowment from the past year.

At our annual granting ceremony on June 11 the Pender Harbour Living Heritage received a grant to restore the Sarah Wray Hall. A piece of living history, the hall was originally the Irvines Landing schoolhouse.

On January 8 the project received another shot in the arm with a presentation of a cheque from MP John Weston. The funding is part of the federal government's economic action plan. The money will help to upgrade the main hall, washrooms; kitchen and multi-use room and will replace water, sewage and heating systems, repair the roof and construct a wheelchair ramp.

A capacity crowd watched and listened as project collaborators, Steve Wright and Bruce Devereux explained and demonstrated how technology, music and the spoken word came together to play with sound. Many of the participants in the final Across

the Lines recording are folks who live at Christenson Village, an assisted-living facility in Gibsons. The extraordinary CD that resulted amazed Devereux, recreation and volunteers manager at the facility and Wright, well-known Sunshine Coast musician. The CDs are available for purchase at Christenson Village.

One of the new endowments created this year came as a result of community response to the jolting news that many children on the Coast were coming to school hungry. In late April Breakfast for Kids coordinator Heather Gordon organized a round table meeting of community leaders to announce the cupboard was bare, that there would not be enough money to continue the breakfast program when school resumed in fall. Businesses and citizens rallied to fund the project and out of that outpouring of concern came the idea to fund an endowment to help future children on the Coast. As of the end of 2012 the endowment had a balance over \$10,000.
